

USTA Junior Team Tennis Schedule and Registration 2025

This is for 8-18 year old beginner, intermediate or advanced players that want to get match experience. Modified no-add scoring will be used. All matches will be held on Mondays. Matches will be played at Normandy and other clubs throughout the Metro area. Coaches do not travel to away matches. Parents must provide transportation to away matches. Our teams will have two, one hour practices per week on Tuesday morning and Thursday afternoon. All team players will rotate throughout the summer playing singles and doubles during these Monday matches to gain experience playing both.

NOTICE: Registration and payment are due By Monday, April 7th. Team creation deadline is May 1st. We need at least 4 players by this date to form a team. If there are not enough players for each age group, players will play up one age category if it matches their ability. If not, you will be given a full refund.

Summer Practice schedule begins Tuesday, May 27, 29, June 3, 5, 10, 12, 17, 19, 24, 26 & July 1, July 3 July 8, 10, 15, 17(Last practice).

State Championships August 1-3 (Only teams that qualify for state will practice after regular season) **Must be able to attend entire weekend at State Championships. State Championships are like an away match.**
